## CHOOSING POLITICAL POLICY

The former guild leader now becomes the government head, and cannot be removed from that position except by choice or typical guild policies. The bulk of decision making however will fall upon the Mayor. Every citizen of the city now has the ability to unlock and pursue a career in city politics. The Govt Head chooses a political policy at this time, which can be approved or disproved by typical guild policy.

### **KEY:**

Pop Vote:	Populace Vote – all citizens logged in within a 48 hour period will be prompted to participate in the vote
Govt Vote:	Governing Body Vote – all government body members logged in will be prompted to vote
Mayor:	Mayor’s Discretion
Consensus:	Applicable to emirates only, all emirates must unanimously agree on the vote

## DEMOCRACY

A democracy is a common form of government where people are not heavily taxed, but benefits are slim as well. The leader is voted on an occasional basis, and most decisions are made between government officials, not concerning citizens too often.

## EMIRATE REPUBLIC

The emirate republic is perhaps the most complex and exotic govt type. The emirate has three equally powerful leaders who can make small decisions independently but require a unanimous emirate consensus to pass important decisions into law.

 Item discount 5% - 10%  
 Mayor 3 voted weekly referred to as 'emirate'  
 Mayor salary - 1% - 7% (each)
